# EXPLANATORY STATEMENT IN RESPECT OF THE SPECIAL BUSINESS PURSUANT TO SECTION 102(1) OF THE COMPANIES ACT, 2013

#### ITEM No. 4

Mr. Subhash Chander Sehgal, was re-appointed as Managing Director of the Board for the second term of 5 years in the 10<sup>th</sup> Adjourned AGM of NEMFPL. And since his term as Managing Director, expires this 15<sup>th</sup> AGM and also pursuant to section 196(3) of the Companies Act, 2013 which requires a *Special Resolution* by the members of a Company to re-appoint a person as Managing Director who has already attained the age of 70 years, therefore the Board hereby requests the members of NEMFPL to pass a Special Resolution to re-appoint Mr. Subhash Chander Sehgal as Managing Director of NEMFPL for a further period of 5 years till the conclusion of 20<sup>th</sup> Annual General Meeting of NEMFPL to be held in the calendar year 2029, based upon his years of past experience of holding the post and leading the Company.

As per PAN card of Mr. Subhash Chander Sehgal his date of birth is 30-04-1952.

### ITEM NO. 5

Mr. Subhas Bhattacharjee (DIN: 02499061) had already retired the post of Independent Director of NEMFPL on 31.03.2024. And in order to comply with the provisions of the Companies Act, 2013 a new Independent Director needs to be with a period of 3 months.

The Board was further informed that and after deliberate discussions and searching the Databank of Independent Directors notified by the Government for prospective it was found that Mr. Prafulla Kumar Saikia, is having sufficient credential for the post of Independent Director of NEMFPL because he has already served NEMFPL as a Director, nominated by Govt. of Assam from 25.07.2016 till 17.04.2021 and has a vast experience in food processing and other industries. He had retired from Govt. of Assam as an Addl. Director, Industries & Commerce on 31.03.2018. And presently he is serving with Assam Foods & Civil Supplies Corporation Limited as Special Executive Officer (PP & MID) post-retirement.

The Board of Directors in its 81st Board Meeting had appointed Mr. Prafulla Kumar Saikia, Ex. MD AIIDC as an additional director to the Board under the category of Independent Director. And this in this 15th AGM the members are requested by the Board to approve the appointment.
